#### 1.5.2.3 Toll-Free Network Access Transport

Contractor's Description of Service, include required service description, features and additional features offered by Contractor: Dedicated network transport services for accessing the AT&T Toll Free Network are provided as follows:

- 1) DS1 supporting up to 1.544 Mbps providing full duplex, four (4) wire, synchronous serial digital data transport. The DS1 services will be channelized (24 multiplexed DS0 channels each at 64Kbps) and will be B8ZS, which is the line coding that allows use of the entire bandwidth of a 1.544 facility, and Extended Super Frame (ESF), which uses a framing bit for non-intrusive signaling and control.
- 2) DS3 supporting speeds up to 45 Mbps on a single circuit or channelized into 28 DS1 channels or 672 DS0 channels.
- 3) Primary Rate ISDN supporting configurations of 'B' and 'D' channels over a DS1 transport facility

Geographic Availability: AT&T Dedicated network transport service is available throughout the United States, in all Incumbent Local Exchange Carrier (ILEC) territories open to competition as defined by the governing Public Utilities Commission where facilities are available either through AT&T-owned facilities or through resale of Incumbent Local Exchange Carrier facilities.

Contractor's Description of Service, include required service description, features and additional features offered by Contractor: International Toll Free services provided through AT&T's Global Toll Free platform. The platform supports all International calling requirements from the following countries with rates based on U.S. termination type (dedicated and switched) and time of day. For international calls, peak periods vary by country. Global Toll Free is a custom network service that will provides a virtual private network with either dedicated (DS1, DS3, ISDN PRI) or switched (Dial 1) terminations.
